# How will a legacy affect my inheritance tax?

Leaving money to a charity in your Will is a great way to leave a positive legacy for the future. It can also reduce the amount of tax paid from the rest of your estate so that your family can get the most out of their inheritance.

You can leave money to a charity in your Will in two ways. You can either specify a named charity in your Will to benefit or leave it to the decision of your Trustees, who will generally consider your charitable preferences if you make it known to them.



You can either gift a cash sum, a particular property/asset or a share of the whole of your residuary estate.

The main benefit of leaving money to charity in your Will is that the gift itself is tax-free. Charitable gifts can also reduce the amount of Inheritance Tax that the rest of your estate will pay. If you leave 10% of your net estate (the amount of your estate once all is paid from liabilities) to charity, your Inheritance Tax liability will reduce from 40% to 36%.

Another benefit is that you can specify how the charity should use your gift if you have a particular wish, but it is always best to discuss your wishes with the charity, to ensure your wish can be fulfilled prior to leaving an instruction in your Will.

#### 5 things to consider:

### Types of legacy

There are three main types of gifts:

Residuary bequest - The balance of your estate, tax (if any), expenses and other types of legacies have been paid. You can leave the whole, or a share, or the residue to Forest Holme Hospice Charity.

Pecuniary legacy- An exact sum of money.

Specific beguest - Personal possessions, such as jewellery, furniture, house, or a car, etc. However, with the passage of time, pecuniary legacies will lose value due to inflation so you may wish to review your Will every few years.
