By ticking the box on the application form, you confirm that you have read, understood, and agree to the following Terms & Conditions:

---

#### **1. Attendance Commitment**

You agree to attend and participate in the Grand Finale of Strictly Extravaganza 2027 at the Lighthouse, Poole on the 23<sup>rd</sup> January, and to be available for the full day, including rehearsals, technical run-throughs and the live evening performance.

---

#### **2. Training Sessions**

You agree to attend and fully participate in a minimum of six (6) 45-minute training sessions between September 2026 and the event date. Training schedules will be confirmed by the Charity and/or appointed dance professionals.

---

#### **3. Sponsorship Commitment**

You agree to raise a minimum of **£1000 in sponsorship** for Forest Holme Hospice Charity.

---

#### **4. Registration Fee**

Upon confirmation of your place, a **non-refundable registration fee of £75.00** is payable to secure your participation.

---

#### **5. Dance Partners**

Participants understand and accept that dance partners will be allocated at the Charity's discretion. You acknowledge that you may not be informed of your dance partner until rehearsals commence or, in some circumstances, until the day of the event.

---

#### **6. Costume and Footwear**

You are responsible for providing your own costume and appropriate dance footwear for your assigned routine unless otherwise advised by the Charity.

---

## **7. Behaviour and Conduct**

Strictly Extravaganza is a fun, supportive and celebratory event in aid of Forest Holme Hospice Charity. As a participant, you are acting as an ambassador for the Charity throughout rehearsals, fundraising activities and on event day.

Be mindful that your actions, both in person and online, reflect on the Charity.

## **8. Health and Safety**

Participation is at your own risk. You confirm that you are physically fit to take part and agree to consult a medical professional if you have any health concerns.

You agree to inform the Charity of any medical conditions that may affect your ability to participate safely.

## **9. Compliance with Instructions**

You agree to follow all reasonable instructions given by dance teachers, choreographers, event organisers and venue staff. Failure to comply may result in exclusion from the event.

---

## **10. Withdrawal**

If you choose to withdraw from the competition, you must notify the Charity as soon as possible.

The Charity reserves the right to determine how any sponsorship money raised will be allocated. Registration fees are non-refundable.

---

## **11. Event Changes**

Forest Holme Hospice Charity reserves the right to cancel, postpone, or amend event arrangements where necessary. Participants will be informed of any significant changes as soon as reasonably possible.

---

## **12. Liability**

Forest Holme Hospice Charity, its sponsors, partners and supporters shall not be held liable for any injury, loss or damage sustained during rehearsals or the event.

## **13. Image and Media Consent**

You consent to photography and videography during rehearsals and the event.

Images, video and audio recordings may be used by Forest Holme Hospice Charity for promotional, marketing and fundraising purposes in all media formats.

#### **14. Alcohol Policy**

Participants may consume no more than **one alcoholic drink prior to their performance**. The Charity reserves the right to prevent participation if a contestant is deemed unfit to perform due to alcohol consumption.
